- **Access to scripts (ATS):** Access to marked examination scripts

- ❖ Please hand the PINK FORM to the Exams office before the deadline date for the service requested.

Post-results service	Service Ref No (SRN)	Details of Service
RoR Service 1: Clerical re-check	R1	This service will include the following checks: <ul style="list-style-type: none"> • that all parts of the script have been marked • the totalling of marks • the recording of marks (For multiple choice tests , only Service 1 re-checks can be requested)
RoR Service 2: Review of marking	R2	This is a post-result review of the original marking to ensure that the mark scheme has been applied correctly. Reviewers will not re-mark the script. They will only act to correct any errors identified in the original marking. This service will include: <ul style="list-style-type: none"> • the clerical re-checks detailed in Service 1 • a review of marking as described above
RoR Service 2 with post-review of marking copy of script	R2a	
RoR Priority Service 2: Review of marking	R2P	This is the same review as Service 2 above, but the script is reviewed as a priority, therefore a request for this service must be submitted to the earlier deadline. (This service is only available for GCE A-level and Level 3 VTQ qualifications)
RoR Priority Service 2 with post-review of marking copy of script	R2Pa	
ATS: Copy of script to support review of marking	A1	This is a priority service that ensures copies of scripts are returned in sufficient time to allow decisions to be made whether a non-priority review of marking should be applied for
ATS: Copy of Script to support teaching and learning	A2	This is a non-priority service to request copies of scripts to support teaching & learning
